CALLED TO ORDER:

Meeting called to order by Lamberto at 7:09pm.

Guest: Jamie from Challenger sports made a presentation regarding Dixon holding a soccer camp this summer. Challenger coaches 6,000- 7,000 kids in Northern California every year. Children that register receive a soccer ball, soccer camp shirt and player evaluation. If they register online within 45 days they also receive a jersey. The camps range from 3-4 year olds 5 days for hour per day for \$63, 4-6 year olds go 5 days a week for 2 hours per day for \$88, 6-16 year old have 3 hour sessions for 5 days for \$105. There is also a small tournament that they hold that is done World Cup style each day. Jamie asked for us to make a decision tonight whether we want to hold the camp or not, to give them time to print up the flyers. If we do decide to go forward with the camp, we will look at putting a link on our website to their's. If anyone is interested in being a host family, you will receive a \$80 rebate. Also, there is a bonus class that they offer for either goalies or a coaching clinic.

*Prior to the guest speaking a group of parents came into the meeting asking to speak also. They were told that you have to notify the board prior to the meeting in order to have time to speak. Allan asked for their names to have the list show they were in attendance, they declined and left.
