HEAD COACH: Daniel has been in communication with Challenger and Lewis wants to set up a date for the Soccer Clinic. Daniel suggests not going with Challenger this year due to very low



sign ups due to costs. Suggest that we hold an in-house clinic and see how well that works. Daniel will coordinate E & F courses in April. (Dixon)

HEAD REFEREE: Charles states there has been an increase in Parent/Coaches arguing with Refs. and their calls during games. This has been very disruptive. He would like to have signs made and posted re: zero tolerance policy to warn everyone and hopefully prevent any altercations. (Club policy to be written). Jason suggests that we can attach to every registration a "Code of Conduct" form signed by every parent. Possibly having it printed on carbon copy papers, so that the Coach, Parent and the Club have it on file.

REGISTRAR: Norma has nothing new to report.

PUBLIC RELATIONS: Chava has nothing new to report.

FIELDS AND EQUIPMENT: Jason met with the City of Dixon re: renovating the fields. The only issue is how to keep everyone off the fields during the renovation period. It will be aerated, seeded, and then fenced off. Martin will see if Teichert will donate the fencing materials. Lamb called Dominguez Bros. and is still waiting for a return call. The old goals have been cut up and removed.

SNACK BAR: Miguel says everything's ok, but nothing active right now. He spent time cleaning up the Snack Bar. Suggests that we remove the old ice machine...broken and leaking. When the season starts again he suggests that when the pizzas are ordered that we have them slice them bigger for selling.

COMPETITIVE COORDINATOR: Last year's Comp. Program only had 3 teams, and were only charged \$100 per child for registration. He has confirmed 6 teams so far. and possibly 2-3 more teams. Registration for 2013 will be \$150. Martin will have a written budget submitted at our next meeting. Martin requests a donation letter with the club tax ID number so that the teams may have them when for requesting donations for their teams.

Chava makes a motion that we allow 3 donation letters with the Tax ID # be released to him for purposes of accepting donations for Comp. teams. All present in favor, Norma abstained. Motion approved. The ad regarding the Comp. tryouts was never put in the newspaper. Chava will contact them and make sure it is added.

NEW BUSINESS

- a. The trial for Natalie has been made for 1/29/13. Hopefully we will not have any more continuations. We will not settle, it will go to trial.
- b. Comp. should be able to pay the fall 2012 City light bill by March.
