CALLED TO ORDER:

Meeting was called to order by Lamberto at 7:43 pm.

APPROVAL OF MINUTES:

The minutes from the September meeting were reviewed. Motion made to approve by Chava, second by Bob. A vote was taken. All were in favor. Motion passed unanimously.

REPORTS

PRESIDENT: SYSL meeting was held in Davis, Lamberto and David Espinoza attended. SYSL reported that they still have no treasurer so they hired an accounting firm. This will cost the SYSL approximately \$1,000. SYSL received a few complaints about scores being run up at games. Coaches were contacted to let them know that they should play around with their line up when a score gets ran up. No dogs at the park and especially if a game is being held at a school (Sacramento games). The city of Dixon is also asking that we not bring dogs during games.

The head referee from SYSL reported that they would like to see age appropriate refs for games and they are asking refs to monitor the end of game hand shake. The referees are also being told that they need to be refereeing in English just to eliminate confusion and preferential treatment.

There are some coaches that are not playing each player ½ the game. If there is a legitimate reason that the child is not playing (behavior issues at practice) then the coach needs to tell the



referees prior to the game. If nothing is done ahead of time then ref needs to report to the league on the game card and the coach will be reprimanded by league.

2016-17 all new United States Soccer rules will kick in and we anticipate a lot of change as a result.

There are two upcoming tournaments: Ernie Hazeltine and the District Six Cup. The club would like to encourage teams to sign up.
