### **CALLED TO ORDER:**

Meeting was called to order by Lamb at 8:00 pm.

### **APPROVAL OF MINUTES:**

The minutes from the June meeting were reviewed. Motion made to approve by Chava, second by Bob. Chava proposes change to June minutes, 3 comp older teams rather than 2. A vote was taken. All were in favor. Motion passed unanimously.
